

RESULTS OF THE "7+7 DAY" BALLOT VOTE FOR THE REDEVELOPMENT OF THE BUKIT FREEHOLD LAND (FROM 8 APRIL 2019 TO 21 APRIL 2019)

On 8 April 2019, an Extraordinary General Meeting ("EGM") was convened to discuss the Redevelopment of the Bukit Freehold Land. At the EGM, the following resolutions ("the Resolutions") were discussed and put before the house:-

- 1. That the General Committee be authorised to implement the redevelopment of the Bukit Freehold Land at the Singapore Island Country Club, Bukit Location and to incur all necessary capital expenditure for the aforesaid development, on the terms of the Option which has the most votes pursuant to Resolution 2.
- 2. That, if Resolution 1 is passed, the General Committee be authorised to implement the redevelopment of the Bukit Freehold Land at the Singapore Island Country Club, Bukit Location and to incur all necessary capital expenditure for the aforesaid development, up to the approved budget of S\$60 million and on the terms of:
 - a) Option 1 "5 Acre Woods" by Park & Associates estimated at S\$59.97 million
 - b) Option 2 "Our Family Forest" by DP Architects estimated at \$\$54.35 million
 - c) Option 3 "Town Club in the Forest" by Eco-ID Architects estimated at S\$43.38 million

The Resolutions were voted upon by way of the Ballot Vote in lieu of the usual manner of voting at General Meetings. The Ballot Vote took place over an extended voting period on a "7+7 day" basis, commencing immediately after the conclusion of the EGM on 8 April 2019.



At the expiry of the first 7-day period which ended on 14 April 2019, a total of 988 eligible voting members had cast their votes. As the number fell below the aspirational target of 2/3 of the membership (5123 members), the voting period was extended for a further 7-day period from 15 April 2019 to 21 April 2019.

Voting closed yesterday, 21 April 2019 at 7.30pm and a total of 1812 members had voted. All ballots cast were counted and witnessed by two representatives from the Audit Committee.

The results of the votes are as follows:-
