Further Steps to Register your Account ("your account")

To proceed to register your account for the purposes of attending the Members' Dialogue, please note the following steps:-

- (i) Upon logging on to the link above, members will be asked to 'Register Now';
- (ii) You will have to key in your full name, Membership Identification Number, your e-mail address and active mobile number. Members are to ensure that their details entered reflect that as set out in the Club's membership records as this will ease the verification exercise;
- (iii) Once these details are submitted, you will receive an email requesting that you verify the registration.
- (iv) Through this verification exercise, you will be asked to create your own account by setting up your password, which will be known only to you;
- (v) As an extra step in the verification process, at each login, members will be prompted to key in their One-Time Password sent to their mobile phones through SMS and this will authenticate the registration.
- (vi) You will then be notified if your registration was successful.
